Students completing the degree plan as outlined will complete their degree with a minor in Marketing, and will have completed all prerequisites for consideration for the Limestone University Masters in Business Administration program.

Students enrolling in this program as freshmen with an SAT score of at least 1200 or ACT score of at least 26, and a high school GPA of at least 3.7 may be eligible to enroll in the Limestone Saint² 4+1 program to earn their Bachelor of Science in Criminal Justice with a minor in marketing, and Masters in Business Administration in 5 years. Transfer students or those who do not meet the above criteria for consideration as freshmen, but who have completed 70 hours of undergraduate work with at least a 3.5 GPA, may apply to the Limestone Saint² Accelerated program to earn their Bachelor of Science in Criminal Justice with a minor in marketing, and Masters in Business Administration in 5 years.
