Candidates are taught to use technology for assessment purposes in the Classroom Assessment courses and in clinical practice. All candidates are required to take Education of the Exceptional Child or Physical Education for the Exceptional Child which includes strategy development for teaching students with disabilities, limited English proficiency, and behavioral issues. Response to Intervention is discussed throughout the course in relationship to full inclusion and the role of the general educator. Candidates are also prepared to participate as an IEP team member. These skills are then reinforced in methodology courses.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

In exceptional child courses, candidates are prepared to participate in IEP teams. They are encouraged to observe IEP staff meetings with their cooperating teacher during student teaching.
